- 2. In this privacy policy, unless the context requires a different interpretation:
  - a. the singular includes the plural and vice versa;
  - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
  - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. reference to any statutory provision includes any modification or amendment of it;
  - f. the headings and sub-headings do not form part of this privacy policy.

#### Scope of this privacy policy

- 3. This privacy policy applies only to the actions of SAI Group Limited and Users with respect to this Website and SAI Alerts App. It does not extend to any websites that can be accessed from this Website including, but notlimited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, SAI Group Limited is the "data controller". This means that SAI Group Limited determines the purposes for which, and the manner in which, your Data is processed.

#### **Data collected**

- 5. We may collect the following Data, which includes personal Data, from you:

#### How we collect Data

#### Data that is given to us by you

#### Data that is collected automatically

  - a. we automatically collect some information about your visit to the Website or usage of the SAI Alerts App. This information helps us o make improvements to Website / App content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
  - b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

## Our use of Data

- 9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Website. Specifically, Data may be used by us for the following reasons:
  - a. internal record keeping;

10. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).

#### Who we share Data with

- 11. We may share your Data with the following groups of people for the following reasons:

- 12. We will use technical and organizational measures to safeguard your Data, for example:

# Your rights

- 17. You have the following rights in relation to your Data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive."
